- OSHA requires that you have a competent person on site while workers are present and the excavation is open.
- Competent Person Training in Excavation is required by the current OSHA Standards, 29 CFR 1926.650 Sub Part P.
- Scope: This sub-part applies to all open excavations made in the earth's surface. Excavations are defined to include trenches.

This class is certified by the Georgia Construction Industry Licensing Board and meets requirements for the Utility Manager and Utility Foreman.
