- If so, you are required by OSHA to understand the hazards involved in confined space and train your employees on the hazards associated with confined space entry.
- OSHA requires that you have a competent person in confined space entry and monitor on each job site while performing confined space entry work.
- This course is designed to train owners, project managers, foremen, and safety personnel on the hazards associated with confined space entry. It covers the techniques, methods, and equipment used to ensure a safe entry.

This class is certified by the Georgia Construction Industry Licensing Board and meets partial requirements for the Utility Manager. This class cannot be used to satisfy any Utility Foreman certification.
