A four hour course for individuals is required to re-certify your NPDES Level 1A (Blue) card which expires every three years. There will not be an exam for this recertification course.



COURSE SCHEDULE:

- Individuals that attend approved course(s) must present the instructor with government issued photo ID and current certification card or proof of valid certification (from GSWCC website).
- Individuals can begin taking continuing education courses 1 year before their certification expires.

REGISTRATION FEES:

• Those individuals with 4 or more hours will receive a new certification card in the mail approximately two weeks before their certification expires.
