This one day Locating Underground Facilities Course is designed for beginners or advanced users alike. Often times it becomes necessary to locate and verify underground facilities while on jobsites. Whether you are locating for the facility owner as a contractor or locating to verify it safe to dig, at some point each excavator will have a need to do so. Why hire a private locator when you could gain the knowledge and competency here. This eight (8) hour course will discuss basic theory of locating through Conductive and Inductive methods. There will be hands on training to ensure that each participant leaves with the knowledge to apply this practice in the field. A Certificate of Completion will be given to all attendees who complete the class. If you take the class for GAS OQ, then further information will be provided by the instructor for continuing certification.
